The IETE has been recognized by the Govt. of India, Ministry of Science and Technology, Department of Scientific and Industrial Research as a Scientific and Industrial Research Organization (SIRO). R&D Cell of IETE Hyderabad Centre has established links with Electronic Hardware and Software Industries in finding solutions to their design and development problems by providing consultancy. For B.E., B.Tech., AMIETE, M.Sc. (Electronics), MCA and M.Tech. students guidance was provided in executing their projects. In July 2012, around 280 students from 16 colleges completed their Projects. For Major Projects around 350 students registered and completed their projects in April, 2013. Senior Executive Committee Members and Guides have gone through the reports and certified the work for submission of the report to the colleges of the students. All necessary facilities were provided to the students for smooth conduct of the Project work. By end of May, 2012 around 50 students registered for Mini Projects and the projects will be completed in July / August, 2013.

Hyderabad Centre has conducted M.Tech. student projects for the benefit of the students community. This year Mahaveer Institute of Science & Technology approached the Hyderabad Centre for doing M.Tech. projects. The Centre has organized meetings on 22.01.2013 and 16.03.2013 with the students, faculty, experts and EC Members and explained the students and faculty of the College about the infrastructure facilities available, project overview like selection of project, preparation of abstract, scope, design analysis results and documentation etc. Subjects experts given clarifications to students and faculty in their domains. 5. Gratuity: Gratuity liability has been accounted on cash basis.
6. Books & Publications: Stock of books of applications & other materials unsold are valued at cost.
7. Grants: Revenue grants received is shown as income on accrual basis and capital grants received for any specific purpose is adjusted against the relevant capital expenditure.
8. R&D Project Expenses: Conveyance reimbursement and remuneration to Guides is paid and booked upon completion of the respective R&D Projects.

B. NOTES ON ACCOUNTS FORMING PART OF BALANCE SHEET

1. Land is leasehold Land and taken from Osmania University on nominal lease rent of Rs.5/- per annum.
2. Annual recurring grants of Rs.3,95,000/- received from Head Quarters under chapter 5 of the Head Quarters manual has been taken as the income of the current year.
3. There are unrecoverable amounts shown under the head of staff advances for an amount of Rs.27,512/- and under the head of sundry debtors for an amount of Rs.11,962/-, for which no provision has been made in the books of account.

1. This has reference to your letter No. IETE/HYD/AGM/2012 dated 11.10.2012 regarding clarifications on various Fund Accounts.

2. In this connection, the required information are as under:-

(a) **Permanent Reserve.** This Reserve represents the sum of all utilized funds, out of transfers from Building Fund, Library Fund, Laboratory Fund, General Fund and Income & Expenditure accounts.

As per the above, the total of the gross cost of the following items, as shown in the Fixed Asset Schedule as on 31 Mar 2012, should have been the same amount shown under the head "Permanent Reserve Account"

(i)	Building	89,80,128
(ii)	Library Books-	9,25,201
(iii)	Lab Equipment	14,34,279
		1,13,39,608

The present balance shown under the head "Permanent Reserve" is Rs 1,00,29,359/-. Therefore, there is a requirement of transferring the difference amount of Rs 13,10,249/- to the Permanent Reserve Account.

(b) General Fund. This Fund represents the accumulated surplus of income over expenditure or vice versa since inception.

(c) Building Fund & Laboratory Fund. These funds are created exclusively for building and laboratory purposes by appropriating a suitable amount from the surpluses generated by the Centre and the amount paid by the HQ IETE for this purposes.

The amounts, as and when utilized, should be transferred to Permanent Reserve Account. The balance amounts under these head represents the actual unutilized amounts and requires to be earmarked. Since the Centre did not have earmarked the balances available in Fund accounts, it appears that the amounts have already been utilized by the Centre and necessary adjustment entries have not been made in the past. It is therefore to be ascertained by the Centre whether these amounts were really appropriated/utilized or not. In case the amount is utilized, you may transfer the amounts to "Permanent Reserve Account" by debiting these Fund accounts.

(d) Prize Fund & Endowment Fund. These Fund balances are represented to the extend of unutilized amount. The interest earned out of the earmarked investments is to be credited to these account and the expenses debited to these accounts. The balance in these accounts should tally with the earmarked investments.

3. We hope the above clarifies your queries. In case of any doubts, please inform us for further clarifications.
